ONE MONTH CERTIFICATE COURSE IN SAFETY & HEALTH FOR SUPERVISORS TO BE EMPLOYED IN HAZARDOUS PROCESS INDUSTRIES UNDER SECTION 41C (b) OF THE FACTORIES ACT, 1948

Date: 01.01.2024 to 30.01.2024

#### THE COURSE PERSPECTIVE:

The section 41C(b) of the Factories Act, 1948, has imposed specific responsibilities on the occupier in relation to hazardous processes which states that every occupier of a factory involving any hazardous process shall appoint persons who possess qualifications & experience in handling hazardous substances and are competent to supervise such handling within the factory.

Realizing the needs of supervisory personnel as above, one month certificate course is being conducted at Regional Labour Institute, Kolkata, to provide an opportunity to gain insight of safe systems & procedures. After this course, the participants will be able to understand, recognize and control the hazards which will result into great degree of risk reduction.

#### **METHODOLOGY & COURSE CONTENTS:**

Training techniques to be used during the course will be lectures, discussions, case studies, laboratory exercises, audio-visual aid & factory visits. The participants will be required to visit a factory as a part of practical exposure and to prepare a Project Report on Factory Visit as a requirement under the syllabus. Following topics will be covered during the course.

- National Policy on Safety ,Health and Environment at Workplace
- Statutory Provisions
- Basic Principles of Accident Prevention
- Techniques of Identification of Hazards
- Prevention & Control Techniques
- Chemical Hazards & Specific Control Measures
- Fire & Explosion Hazards
- Health Hazards due to chemical exposures
- Chemical Emergency Preparedness
- Counselling & motivating for safety & health
- Others (Safety Audit, OSHAS, Environmental Management Systems, Communication, training Cycle, Behavioral & Physiological aspects, total safety Culture, resilience Engineering)

At the end of the course, the participants will be required to undergo an examination comprising of Laboratory work (Safety, Hygiene and Industrial Medicine), Oral examination based on project/laboratory work and written examination. Certificates will be awarded to the successful candidates.

#### **COURSE DURATION:**

The course will be conducted **from 01.01.2024 to 30.01.2024** Full time (minimum 6 contact hours per day) - 4 weeks (Two weeks classroom teaching followed by one-week project work and on completion of which a further one-week classroom teaching). The teaching hours at the Institute will be from **10:30 a.m. to 5 p.m.** 

#### **FACULTY:**

The faculty will be the officers from various disciplines of the Institute, specialists from Industries, different Institutions & Government departments.

### **QUALIFICATIONS FOR ADMISSION:**

(i) A degree in chemistry or a diploma (three years full time) in any branch of engineering or technology or equivalent with not less than 5 years' experience.

OR

(ii) Master's degree in chemistry or a degree in any branch of engineering or technology or equivalent with not less than 2 years' experience.

NOTE: The experience stipulated above shall be in process operations and maintenance, in any hazardous process industry.

#### ATTENDANCE:

Minimum 80% attendance shall be required for appearing in the final examination. The minimum requirement is mandatory even if a candidate is declared sick on medical ground.

#### **FEE & OTHER EXPENSES:**

Institute Fees: Rs. 7,500/- per participants - for the entire course. The fee is payable immediately on receipt of conformation of seat in the course & before joining the course by means of Crossed Demand Draft in favor of "Administrative officer, Regional Labour Institute, Kolkata" payable at Kolkata or online payment through www.bharatkosh.gov.in.
