The Identification, Evaluation and Control of these hazards are very much important to Management / Executives Engineers /Supervisors, Safety Officers. Rapid industrialization contributes to increase in hazards and occupational illnesses near future. To overcome these issues, implementation of the best evaluation practices are requires understanding of Industrial Hygiene, at industrial workplace, ports and construction work. The Second Schedule of the Factories Act, 1948 mandate compliance to permissible limits of exposure (PLE) of certain chemicals and Physical hazards in the work place Environment. This calls for identification, evaluation and control of these workplace Environment and hazards mandatorily on the part of the Management in order to keep the hazards within control. The objective of this program is to make aware participants over theoretical and practical aspects on Industrial hazards their evaluation and control management.
